Recipe Corner

Patti's Recipe for Fluffy Strawberry Fruit Dip



Ingredients:

1 carton (8 ounces) spreadable strawberry cream cheese

2 tablespoons strawberry preserves

1 carton (8 ounces) frozen whipped topping, thawed

1 jar (7 ounces) marshmallow crème Assorted fresh fruit

Directions:

In a bowl, beat cream cheese and preserves until blended. Fold in whipped topping and marshmallow crème. Cover and refrigerate until serving. Serve with fresh fruit (or crackers).

You can try other combinations like blueberry cream cheese and grape jelly, plain cream cheese with orange marmalade, or pineapple cream cheese with pineapple jelly topped with coconut. Instead of fruit I have used vanilla wafers but grahams cracker, plain bagels (chips), or toast will work. Be creative.

Pile-Up Accident on Interstate 81

On March 28, 2022, a terrible and dangerous accident occurred on Interstate 81, 8 miles from our principal office, during a snow squall and whiteout conditions. According to WNEP, a local news station, about 80 vehicles were involved in a pile-up on Interstate-81 near the Minersville exit and included an immense fire that burned for a day. Numerous deaths were reported as a result of the accident. The Interstate re-opened after nearly two days of closure with assistance from traffic control and emergency services. The accident was broadcasted and shown on news channels around the country. When large-scale accidents occur, such as the one that occurred on Interstate-81, it is especially important to drive with caution and know how to react.

Whiteout conditions and snow squalls were two dangerous factors that impacted the pile-up accident. Whiteout conditions define snowy weather that makes it difficult to see and drive. Combined with high winds and rapidly drifting snow, it can become a detrimental factor when driving. If possible, it is safer for vehicles to remain off the road until conditions become lighter or the snow stops. Snow squalls are instant and sudden amounts of heavy snow that accumulates very quickly. Snow squalls are very similar to a whiteout; however, snow squalls typically occur in one centralized location. These weather conditions mixed with heavy traffic can lead to very dangerous driving conditions.

During bad weather conditions, it is important to drive at lower speeds and maintain a safe distance between other vehicles. Maintaining a space of multiple cars between your vehicle and others will allow for faster reaction times and to brake if needed. When visibility is very low, such as during heavy snow, all vehicles should follow safety protocols. It is also recommended to turn on hazard lights. This will encourage other vehicles to follow in order to remain on the road and keep a safe distance.

If a large-scale accident occurs, be prepared to remain in traffic for a prolonged period of time and to respond to traffic changes. Traffic workers may need to redirect traffic, close lanes, or re-route traffic to another area. Following safety protocols will help traffic stay away from the accident area and move to a safer area. Serious, and sometimes deadly, auto accidents can occur unexpectedly and without warning. It is important to know what to do and how to react in these circumstances.

Recall on Exactech Hips and Knees Implants

Exactech issued a huge recall on thousands of hip and knee implants. Exactech is a very popular company that creates implants and technologies used during surgical practices. In 2021, the company recalled thousands of implant replacements because of defective parts that were determined to cause injuries. For decades, surgeons have used Exactech implants during joint replacement surgeries. In fact, Exactech researched that tens of thousands of recalled hips and knee parts were implanted since they were created. Therefore, many people may be impacted by this major recall. Summer Auto Accidents

In the summer, many vehicles will be on the roads for long travels. During the summer season, auto accidents and injuries can become prevalent. In addition to accidents, drivers and passengers can also experience health issues. Before driving during in the summer, it is important to be aware of the potential dangers that can occur.

With many cars, tractor-trailers, motorcycles, and public transportation systems traveling, there is an increased chance of any auto accident occurring, including rear-end collisions. Since many people go on vacations during the summer, there are also drivers who have been on the road for a long period of time. Accidents are more likely to occur when there are many vehicles driving on congested roads. Statistically, there are also more inexperienced drivers on the road during this time, and they do not have years of experience with heavy traffic and auto accidents. As a result, they can have the potential of being involved in an accident if they are not aware of their surroundings.

Tire accidents are common to occur in summer. In fact, the summer season is sometimes referred to as "tire blowout season". When temperatures are high, roads can become extremely hot. It is not unusual in the summer for tractor-trailers and other vehicles to have tire blowouts, which occur as a result of low tire pressure. Tire tread separation can also cause tire blowouts. In addition to tire blowouts, temperatures can also affect the performances of vehicles. In most cases, it can cause vehicles to use more fuel to operate. To support your car's engine during the summer months, it is recommended to stay updated on oil changes and other safety precautions. If these factors are not maintained, vehicles can experience internal damages.

Vehicles are not the only factor that can be affected by the summer weather. Drivers and passengers can also receive negative side effects from hot temperatures. For example, divers can report feeling dehydrated or fatigued from the incredibly hot temperatures. This can be potentially dangerous for drivers because they may become inattentive to the road. Inattentiveness can cause slow reaction times and accidents if drivers are not careful. Heat strokes are also possible to occur. According to the Centers for Disease Control and Prevention, heat strokes occur when the body is unable to react and maintain normal body temperatures.
