The selection process for Rising Stars is identical to Super Lawyers. However, there is one difference in that attorneys must be under the age of forty or have been practicing law for ten years or less.

## **Recipe Corner**

# Patti's Cheese Ball Recipe

#### **Ingredients**:

- 1 pound of Velveeta cheese
- 2 packages of 8 oz cream cheese, softened
- 2 cups of grated cheddar cheese
- 1 teaspoon of Worcestershire sauce
- <sup>1</sup>/<sub>2</sub> teaspoon of garlic powder

#### **Directions:**

Advise the Waiting Period Time. It is important to call and hire an attorney as soon as a disabling injury occurs. Attorneys will be able to advise clients about their waiting period when applying for benefits. For Social Security Disability Insurance, there is an approximate 5-month waiting period that must occur before receiving benefits.

**Explain the Eligibility Requirements and the Social Security Disability Blue Book.** Attorneys have expertise knowledge on many areas of Social Security Disability, including eligibility. In order to become eligible to receive benefits, people must meet certain requirements. Common examples include having a qualifying disablement, received a certain number of work credits, or have a special circumstance. The Social Security Disability Blue Book by the Social Security Administration provides a detailed explanation of disablements and how people would be eligible to receive benefits from their impairments.

**Resolve Problems with Applications.** It can be difficult to receive compensation from Social Security Disability if an impairment does not meet the Social Security Disability's definition of the disability. For example, Social Security Disability defines a disability as a disablement that impairs a person's ability to work and is predicted to last at least a year. There are other circumstances in which people can receive benefits if other requirements are completed.

**Responding to Denied Claims.** Initially, most Social Security Disability applications are denied. Although there are other causes, this can generally be a result of insufficient information or an incomplete application. By hiring a Social Security Disability attorney, they will be able to assist people with their case and ensure that it has the best potential of approval once it is re-filed.

#### Medical Marijuana Reimbursement under the PA Worker's Compensation Act

In a pair of opinions filed on March 17, 2023, the Pennsylvania Commonwealth Court concluded that insurers must reimburse claimants who lawfully use medical marijuana to treat an accepted work injury when the use of medical marijuana is reasonable and necessary. The opinions in *Fegley, as Executrix of the Estate of Paul Sheetz v. Firestone Tire & Rubber (WCAB)* and *Appel v. GWC Warranty Corporation (WCAB)*, both penned by Judge Anne E. Covey, reach the same conclusion but by way of different petitions filed by the parties.

Both opinions included a nearly identical analysis of the PA Workers' Compensation Act, the PA Medical Marijuana Act, the Federal Drug Act and a provision of the Federal Consolidated Appropriations Act as well as a comparison with laws of other states that have enacted a medical marijuana statute. Ultimately, Judge Covey concluded that there is a distinction between providing coverage for a treatment and reimbursing the out-of-pocket expense of a treatment. The opinion explains that although the specific language of the PA Medical Marijuana Act states that an insurer cannot be required to provide coverage for medical marijuana, the statute does not prohibit coverage or reimbursement. And, because the PA Workers' Compensation Act mandates employers to reimburse claimants for out-of-pocket costs of reasonable and necessary treatment related to the work injury, employers are required to reimburse claimants for medical marijuana.

To date, no further appellate action has been taken on either of these cases. However, legislation has been offered to codify the requirement of insurers to reimburse claimants for the out-of-pocket cost of medical marijuana.
